MINUTES OF THE REGULAR MONTHLY MEETING OF THE FIFTY LAKES CITY COUNCIL June 13th, 2023

The Regular Monthly Meeting of the Fifty Lakes City Council was held on Tuesday, June 13th, 2023, at City Hall at 6:00 pm. The following officers were present: Toni Buchite, Mayor; Gary Staples, Toni Buchite, Jill Radman, Mark Bradley, Randy Zeigler, Council Members; Ann Raph, City Clerk; Jessica Istvanovich, Deputy Clerk; Chad Wosmek, Maintenance Supervisor; Diana Johnson, Liquor Manager.

The Pledge of Allegiance was recited.

<u>Consider Agenda</u>: Additional items added to the agenda were appointing of an acting Mayor under New Business. A report on the sale of scrap metal and a dust guard schedule under Road Construction and Maintenance. An approval of an AC compressor and vented hood for kitchen under Liquor Store.

MOTION MADE BY MR. BRADLEY AND SECONDED BY MR. STAPLES TO ADD ADDITONAL ITEMS TO THE AGENDA. When polled: Ms. Buchite, aye; Mr. Bradley, aye; Mr. Staples, aye; Ms. Radman, aye. (Mr. Zeigler not yet appointed) Motion carried.

Consent Agenda: Acting Mayor Buchite requested consideration of the consent agenda. Council reviewed: Council Meeting Minutes for Regular Meeting May 9th, 2023, and Special Meeting May 24th, 2023; Treasurer's Report: Payment of bills in the amount of \$158,074.30 including Check No #45333 through #45425; Fire and Rescue Minutes; Resolution 2023-09 Fire Relief Association Donation.

MOTION MADE BY MR. BRADLEY AND SECONDED BY MS. RADMAN TO APPROVE THE CONSENT AGENDA AS PRESENTED. When polled: Ms. Buchite, aye; Mr. Bradley, aye; Mr. Staples, aye; Ms. Radman, aye. (Mr. Zeigler not yet appointed) Motion carried.

MOTION MADE BY MR. BRADLEY AND SECONDED BY MS. RADMAN TO APPOINT THE ACTING MAYOR, MS. BUCHITE, TO FULL TIME MAYOR. When polled: Ms. Buchite, aye; Mr. Bradley, aye; Mr. Staples, aye; Ms. Radman, aye. (Mr. Zeigler not yet appointed) Motion carried. The Council received 5 applications to fill the vacant council seat. The applicants attending the meeting were asked to give a brief introduction. Discussion followed. Mayor Buchite thanked every applicant for their interest.

MOTION MADE BY MR. STAPLES AND SECONED BY MS. RADMAN TO APPOINT R. ZEIGLER TO FILL THE VACANT COUNCIL MEMBER POSITION. When polled: Mayor Buchite, aye; Mr. Bradley, aye; Mr. Staples, aye; Ms. Radman, aye. (Mr. Zeigler not yet appointed) Motion carried. Mayor Buchite and Council Member Randy Zeigler were sworn in by clerk, Ann Raph.

Mr. Stancer, Chair of the Planning Commission, gave a review to the council of the weather siren that is proposed to be located adjacent to the Horvath cell tower. Mr. Stancer presented information on two different emergency weather sirens; Federal Signal model 2001-130 rotating siren 130db and American Signal model T-128 rotating siren 129.5db. The council thanked Mr. Stancer for his review and research.

MOTION MADE BY MR. STAPLES AND SECONDED BY MS. RADMAN TO APPOINT MR. BRADLEY AS ACTING MAYOR. When polled: All members voted aye. Motion carried.

MOTION MADE BY MAYOR BUCHITE AND SECONDED BY MR. STAPLES TO APPOINT MR. ZEIGLER AS LIQUOR STORE LIASION AND MR. STAPLES AS PLANNING COMMISION LIASON. When polled: All members voted aye. Motion carried.

<u>Planning and Zoning:</u> The Planning Commission held their regular meeting on May 23rd, 2023, at which there were no public hearings.

<u>Parks</u>: The council discussed getting bids to complete the carpentry portion of the park pavilion. The council discussed the additional bill from Anderson Brothers that was for the preparation for the pickle ball court area. MOTION MADE BY MR. BRADLEY AND SECONDED BY MS. RADMAN TO APPROVE THE ADDITIONAL BILLING OF \$700.00 TO ANDERSON BROTHERS. When polled: All members voted aye. Motion carried. The council discussed lighting and electrical for the park pavilion.

MOTION MADE BY MR. BRADLEY AND SECONDED BY MR. ZEIGLER TO APROVE UP TO \$3,200.00 FOR LIGHTING AND ELECTRICAL AT THE PARK PAVILION TO NORTHERN LAKES ELECTRIC, INC. When polled: All members voted aye. Motion carried.

<u>Public Safety:</u> Jesse Anderson, Assistant Fire Chief, reported 4 medical calls and 2 fire calls for the month of May.

<u>Road Construction and Maintenance:</u> Council was made aware of concerns about excessive speed of vehicles on North Eagle Lake Road. The council advised maintenance to move a radar sign to North Eagle Lake Road. Mr. Wosmek, maintenance supervisor, arranged the sale of scrap metal to the amount of \$500. Mr. Wosmek reported that the dust guard for the city roads will be laid by the end of the week. Due to a shortage of materials only a single pass will be put on at this time to ensure that all roads are covered.

<u>Liquor Store</u>: Ms. Johnson, Bar Manager, reviewed with the council the upcoming Fifty Lakes Day event, the intended removal of the horseshoe pit due to lack of interest, repairing of some damaged bar stools and purchasing of dining chairs from P. Miller. Ms. Johnson stated that the A/C compressor needs to be replaced for the on/off sale. MOTION MADE BY MR. BRADLEY AND SECONDED BY MR. STAPLES TO ACCEPT THE BID FROM SCR OF \$5724.24 AND TO ALLOW ADDITIONAL FUNDS TO COVER FRIEGHT, ELECTRICAL WORK, REFRIGERANT AND APPLICABLE TAX. When polled: All members voted aye. Motion carried. MOTION MADE BY MR. BRADLEY AND MR. ZEIGLER TO ACCEPT THE ILLINOIS CASUALTY COMPANY BID FOR DRAM INSURANCE. When polled: All members voted aye. Motion carried. The council discussed with Ms. Johnson increasing the size of the vent hood in the kitchen. Ms. Johnson will research and obtain bids.





Location

Site Shading





Estimated PV System Energy Production by Month (kWh)



The City of Fifty Lakes approved your variance request to construct (a portion of) a 640 sf dwelling addition within the OHW level setback on the property located at 41282 Peninsula Road.

The approval was made by the Board of Adjustment at their meeting on June 27, 2023 based on the following findings of fact and with the following conditions of approval.

Findings of Fact:

- 1. The subject property is located at 41282 Peninsula Road and is zoned "Shoreland Residential" (East Fox Lake-General Development).
- 2. The variance request is to construct (a portion of) a 640 sf dwelling addition within the OHW level setback on the property located at 41282 Peninsula Road. The proposed addition is located on the north side of the pre-existing dwelling approximately 65' from the OHW level (75' required).
- 3. Approximately 320 sf of the dwelling addition is proposed to be constructed within the OHW level setback area. The remainder of the proposed addition is proposed to be constructed within the building envelope.
- 4. The existing single family dwelling is located 36.5' from the OHW level of East Fox Lake.
- 5. The proposed impervious surface coverage of the property is 20% (25% allowed.)
- 6. The DNR has been notified of the request and has not provided comments.
- 7. The granting the variance will put the property to use in a reasonable manner not permitted by the zoning ordinance.
- 8. Does the property have unique circumstances that were not created by the landowner?
 - a. Yes, the pre-existing dwelling was constructed by a previous landowner before the establishment of the State Shoreland Rules.
- 9. If the variance is granted, will the essential character of the locality remain consistent?

- a. Yes, constructing a dwelling addition will not alter the essential character of the neighborhood. The improvement will not be visible from the right-of-way and not highly visible from adjacent properties or the lake.
- 10. Will the variance, if granted, be consistent with the comprehensive plan and be in harmony with the purpose and intent of the City of Fifty Lakes ordinances?
 - a. Yes, the request, with conditions, is consistent with the purpose and intent of the zoning ordinance and the following goal in the comprehensive plan, "To preserve the natural character and environmental quality of the lakeshore and still allow reasonable use for property owners and the public."
- 11. Has the variance request been made based on reasons other than economic considerations alone?
 - a. Yes, the request has been made on factors other than economic considerations.

Conditions of Approval:

- 1. Stormwater runoff generated by the proposed addition shall be directed to the swale areas identified on the survey.
- 2. The reconstructed roof on pre-existing dwelling shall contain gutters and downspouts located on the north side and directed away from the lake.

The existing siren is outdated and needs to be replaced and the new siren will provide improved siren alert coverage in the areas of Kego, Eagle, Mitchell, and Fox lakes.

These sires are critical, to the community of Fifty Lakes, for severe weather alerting of residence and visitors to the Fifty Lakes area. The sirens will be activated by Crow Wing County Public Safety and will be operated by battery backup so they can still be utilized during an power outage.

The sirens will be Federal Siren and will be 130db rotating sirens.

The City of Fifty Lakes is a rural farming, forested, lake area offering camping, golf, snowmobiling, hunting and offroad vehicle outdoor recreation. The heavily forested land along with hilly terrain make the area conducive to being outdoors and enjoying nature. To protect those citizens and visitors enjoying outdoor recreation the City sees a need to improve the current weather warning system.
